## APPROVAL OF MINUTES

Regular Board of Directors Meeting, March 10, 2014 – It was moved by Tim Cole and seconded by Joe Hadacek to approve the minutes as presented. The motion carried unanimously.

## MAINTENANCE REPORT

Joe Hadacek reported that all the mulch purchased has been installed. Tim/Raintree will be buying an additional 30 bags to finish the project. Half the speed bumps have been painted in the community and the most of the fencing in the pool area has been cleaned. There are still irrigation leaks between building 13 and 11 as well as 11 and 15. Repairs need to be made on some garage doors frames and window frames on building 27, this was noticed after the pressure washing was done. There is a piece of gutter down on building 14 and the light is still out on Raintree Drive. Caulking needs to be done at 2926 Claremont Drive as well. There are still some hose bibs leaking on the garage units.

## POOL REPORT

Ms. Childress reported that the pool is close due to the motor not working and she also stated that a new belt is needed. The pool should be up and running within the next two days. There have still been some problems with people from other communities coming to the Raintree pool. Ms. Childress asked all homeowners to please report to security if you think someone is inside the pool area and doesn't reside in Raintree. Jeanie also reported that the pool light is still out.

Tim Cole made the motion to approve up to 800 bags of mulch for the community. Joe Hadacek seconded the motion. All were in favor. Motion carried.
